It is understood that in a discussion held on 31 May 1963 between Mr. Gilpatric and Mr. Kaysen of your staff, it was agreed that the Department of Defense and the Atomic Energy Commission would manage the matter of installation of the Permissive Action Link (PAL) devices as appropriate and that you would be notified of major changes to the PAL schedule.

Attached for your information is a modified PAL installation schedule for Category A and B, recently approved by the Department of Defense. The changes were made to place the installation program in phase with the availabilities of the PAL equipment as indicated by the latest AEO production schedules.


